

RELEASE AND WAIVER OF LIABILITY

PLEASE READ THIS DOCUMENT CAREFULLY, BY SIGNING OR SUBMITTING YOUR FORM ONLINE, YOU ARE GIVING UP LEGAL RIGHTS. In consideration for being permitted to participate in the SGX PAIX and related activities (collectively, "Activities") conducted by GJM Enterprise LLC, doing business as SGX PAIX (herein referred to as the "Company"), I hereby agree as follows:

ASSUMPTION OF RISK:

I agree that I am voluntarily participating in the activities offered by the Company including but not limited to participating in the SGX PAIX. I am assuming, on behalf of myself, all risk of personal injury, death or disability to me or others that might result from such participation, or any damage, loss or theft of any personal property which I may incur. I understand that participating in the SGX PAIX has inherent risks. I also understand and I have been warned that if I have had any previous injuries, I am at heightened risk of injury. I understand and accept the above risks of bodily injury related to the activities.

RELEASE OF LIABILITY:

I agree on behalf of myself and my/their personal representatives, successors, heirs, and assigns to hold the Company and its affiliates, instructors, officers, directors, agents, employees, and members (collectively, the "Releasees") harmless from any and all claims or causes of action arising out of my participation in the Activities, including without limitation, workouts and challenges.

I expressly release and discharge Releasees from any and all liability, claims, demands or causes of action whatsoever arising out of any damage, loss, personal injury or death to me, while participating in any of the activities, including without limitation, the workouts, challenges, strenuous bodily movement, and exposure to extreme conditions.

This release is valid and effective whether the damage, loss or death is a result of any act or omission on the part of any of Releasees or from any other cause. This Waiver and Release of all liability includes, without limitation, injuries, illness, or accidents, which may occur as a result of (a) participating in the SGX PAIX or (b) slipping and falling while performing all Activities within the SGX PAIX.

I understand that I voluntarily give up my right to sue the above-mentioned parties.

I further grant the Company the right to use photographs and/or videos of me and to use my name, face, likeness, voice and appearance in connection with publicity, advertising, and promotional materials without reservation or limitation.

I ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS RELEASE AND WAIVER, HAVE HAD ADEQUATE TIME TO REVIEW AND CONSIDER THIS RELEASE AND WAIVER, AM NOT UNDER ANY DURESS OR UNDUE INFLUENCE, AND FULLY UNDERSTAND THAT IT IS A RELEASE OF ALL LIABILITY AND A WAIVER OF ANY RIGHT THAT I MAY HAVE ON BEHALF OF MYSELF TO BRING A LEGAL ACTION OR ASSERT A CLAIM FOR DAMAGE, INJURY OR LOSS OF ANY KIND AGAINST THE RELEASEES. IF ANY ATTEMPT FOR CLAIM IS MADE, I UNDERSTAND I WILL BE RESPONSIBLE FOR ALL DEFENSE COSTS INCURRED BY THE COMPANY.
